Introduction

IFPA Annual Report for 2008

Since its foundation in 1969, the Irish Family Planning Association (IFPA) has been deeply committed to promoting reproductive and sexual health and choice.

2008 was a busy and productive year for the IFPA. Our medical and pregnancy counselling services were much in demand. We provided contraceptive, sexual health and crisis pregnancy services to over 27,500 clients. Sadly, a substantial increase in demand for services among medical card clients combined with insufficient funding from the Health Service Executive (HSE) forced the IFPA to suspend medical card services for a period in 2008. The episode echoed a similar occurrence in the mid 1980s, when the IFPA saw an increasing number of women with medical cards who could not afford to pay for family planning services. Fast forward to 2008 and it is clear that family planning for women in lower socio-economic groups is still not a priority for the Irish Government.

On a positive note, the IFPA ran another highly successful European Cervical Cancer Prevention Week in January. In September the long-awaited and much overdue national cervical screening programme, CervicalCheck, was introduced. As a registered smear taker the IFPA played a key role in the delivery of this vital programme. A national cervical screening programme has been a long standing policy priority for the IFPA. Indeed the roll out of CervicalCheck in 2008 came 15 years after the IFPA made a submission to the Department of Health & Children about the need for such a screening programme. The Government's decision to scrap plans for an accompanying national cervical cancer vaccine programme due to budgetary constraints is regarded by the IFPA as a

massive missed opportunity. The IFPA advocates for a reinstatement of the full vaccination programme for girls age 12 including a full catch up programme for girls aged 13 to 15. Female Genital Mutilation (FGM) was a key advocacy issue for the IFPA in 2008. The IFPA produced the National Action Plan to Address Female Genital Mutilation in consultation with partner organisations. This landmark document is effectively a blueprint setting out how to address FGM in Ireland and in Irish development policies. 2008 was another busy year for our counselling services and we continued to witness the negative impact of Ireland's effective ban on abortion on women's health and wellbeing. Our Training & Education Department launched the Speakeasy programme, an initiative which provides parents with the information and skills to talk to their children about relationships and sexuality. The IFPA hosted a conference focusing on the reproductive and sexual needs of the drug using community – a first for Ireland. Following on from the success of 2007, the IFPA also hosted the second Young Decision Makers Conference.

We would like to take this opportunity to say thanks to all our current and former staff, board members, funders, supporters and clients. We look forward to working with you all in 2009.

About IFPA

The IFPA was established in 1969 by seven volunteers driven by a desire to make family planning services and information available to everyone. Since then the IFPA has been to the fore in setting the agenda for sexual and reproductive health and rights. Today the IFPA is a national voluntary organisation and registered charity, which offers a comprehensive range of services designed to promote sexual health and support reproductive choice.

The IFPA provides medical services from its clinics in Dublin city centre and Tallaght as well as crisis pregnancy and counselling services at 11 centres nationwide. The IFPA delivers family planning courses to doctors and nurses and also provides education and training on reproductive health issues to a variety of groups including service providers, young people, parents and community groups. All of these services are offered on a not-for-profit basis.

With our track record in providing high quality medical and contraception services, crisis pregnancy counselling and education, IFPA is a respected authority on sexuality and health and is regularly called upon to contribute expert opinion and advice. IFPA works with partner organisations and civil society to raise awareness of the importance of sexual and reproductive health at home and all over the world.

Vision

At the IFPA we envisage an Irish society where all people can enjoy a fulfilling sex life and can make informed choices in their sexual and reproductive lives; where there is full access to high quality information, education and health services regarding sex, sexuality, conception, contraception, safe abortion and sexually transmitted infections.

Medical Services

In 2008 the IFPA provided over 26,000 sexual and reproductive health consultations at our clinics at The Square, Tallaght and Cathal Brugha Street, Dublin 1. IFPA clinics offer a comprehensive range of health services including contraceptive advice; cervical screening; infertility, menopause and menstrual health advice; psychosexual therapy and comprehensive STI screening services.

Key Points in 2008:

- » The most significant development in 2008 was the roll out of the national cervical cancer screening programme, CervicalCheck in September. As a registered smear taker IFPA played a key role in the programme and in the final months of 2008 1,108 women were screened at IFPA clinics.
- » An increase in demand for services among medical card clients combined with insufficient funding from HSE forced the IFPA to suspend medical card services for a period.
- » IFPA was forced to suspend the provision of services to medical card clients at its main Dublin clinic due to a lack of funding from the HSE resulting in a noticeable reduction in attendances at the clinic.
- » 932 people attended our clinics for STI screenings.

We provided the following services for women with medical cards: women's health checks, advice and therapies, including breast examination, cervical smear testing, sexually transmitted infection screening, rubella testing, periods, menopause and safer sex advice, contraception services and free pregnancy testing.

Medical Training

In 2008 there was continued demand for the IFPA's Family Planning Courses, which have been running since 1977. Over 150 doctors and nurses took part in these post-graduate education programmes during the year. The courses are run over two days taking place in February and September. These education programmes are certified by the Joint Committee of Family Planning and have An Bord Altranais Category 1 approval. They comprise two days of theoretical training and six sessions of practical training.



IFPA's Emergency Contraception Survey

The emergency contraceptive pill (ECP) is a very safe and responsible method of preventing pregnancy when regular contraception has failed, no contraception was used or in the case of sexual assault. ECP is made out of the same hormones as regular contraception and works in a similar way. There are no serious side effects associated with it and no absolute contra-indications.

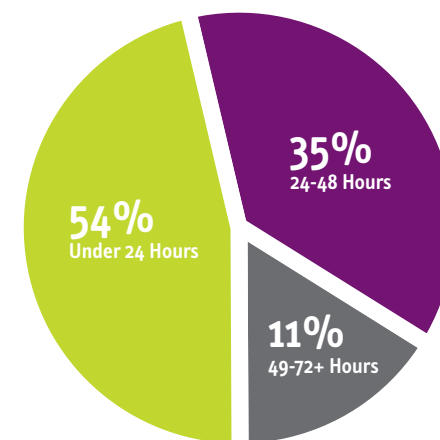
The IFPA believes there is no medical reason why the emergency contraceptive pill should not be available over-the-counter in pharmacies in Ireland without age restrictions. New research undertaken by the IFPA sheds light on the length of time taken to access ECP, the age profile of women requesting the emergency contraceptive pill and the reasons and frequency of use.

The survey analyses all new clients who presented to IFPA's Cathal Brugha Street Clinic for emergency contraceptive services in 2008, representing 1,351 women in total. It did not include pre-existing clients who requested emergency contraception services in that time or clients presenting for other services

Nearly half of all women (46%) surveyed presented for emergency contraception more than 24 hours after under-protected sex. Given that ECP is more effective the earlier it is taken, this delay in accessing ECP reinforces the case for improving access.

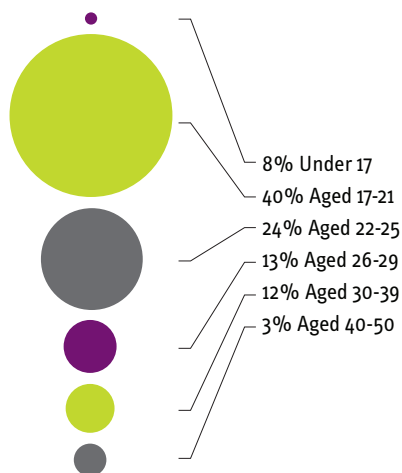
Time taken to access the emergency contraceptive pill:

- » 54% of women presented for emergency contraception services within 24 hours of under-protected sex.
- » 35% of women presented for emergency contraception services between 24 and 48 hours after under-protected sex.
- » 11% presented for emergency contraception services 48 hours or more after under-protected sexual intercourse.



Age Profile:

- » Over half of all women requesting the emergency contraceptive pill were aged 22 or older (52%).
- » Four out of 10 (40%) clients were aged between 17 and 21.
- » 8% were under the age of 17.
- » Almost one quarter (24%) were aged between 22 and 25 years of age.
- » 13% were aged between 26 and 29.
- » 12% were aged between 30 and 39 years of age and a further 3% women were aged between 40 and 50.



Reason for Use:

- » 71% of women requesting the emergency contraceptive pill said it was because no contraception was used.
- » 17% said it was because of condom failure.
- » 10% reported pill failure. Forgotten pill was the most common reason given for pill failure (53%). Antibiotic use was the second most common cause of pill failure (9%).

* Note: this sample group only represents new clients from January 2008. Results which include the full cohort of clients might give different results. Research on pre-existing clients seeking emergency contraception is underway.

Frequency of Use from Jan 2008 to August 2009

- » The vast majority (86%) of women were prescribed ECP only once in this time in the last 20 months.
- » 11% of women were prescribed ECP twice in this time in the last 20 months.
- » 2% were prescribed ECP three times and a further 1% were prescribed ECP on four or more occasions in the last 20 months.

Other findings:

- » Most women (82%) requesting ECP had no previous pregnancies. 6% had experienced one pregnancy and a further 2.66% had been pregnant on two occasions.
- » 1.48% of women did not require ECP.

Counselling Services

The IFPA provides crisis pregnancy counselling services at 11 centres throughout Ireland. These are located in Cork, Tallaght, Dublin city centre, Dundalk, Galway, Gorey, Letterkenny, Limerick, Monaghan, Sligo and Waterford. The IFPA's counselling service provides a safe and completely confidential space for anyone who wishes to explore their feelings around their unplanned pregnancy or a wanted pregnancy that has developed into a crisis pregnancy due to changes in circumstances.

IFPA's counselling service is non-directive; it respects women's autonomy and the right of every woman to choose for herself how to deal with her situation. Also in September there was significant media focus on the news that the IFPA to suspend medical card services for a period because of insufficient funding from HSE. In 2008 IFPA's counselling services provided support to

1,163 clients. This service is free and is funded by the Crisis Pregnancy Agency. IFPA also provides post-abortion support and medical consultations. 2008 was another busy year for IFPA's advice and information service with a total of 4,558 calls made to our national pregnancy helpline (1850 49 50 51).

Key Points in 2008:

- » Establishment of a new counselling service in Gorey, Co Wexford in May.
- » Provision of counselling support to three women challenging Ireland's ban on abortion at the European Court of Human Rights.
- » Monitoring activity of rogue crisis pregnancy agencies.
- » Monitoring travel and access to legal abortion services in Holland and Spain.
- » Monitoring travel and visa restrictions for women born outside Ireland seeking legal abortion services abroad.
- » Highlighting the issue of foetal abnormality diagnosis and care.
- » Improving access to ultrasound and medical diagnostics.

Media Work

to serve as a respected source for information on sexuality and health. We work with the media by providing briefings and support as well as issuing statements on issues which relate to our strategic goals.

Much of our press work in the early part of the year centred on European Cervical Cancer Prevention Week. The Government's decision to reduce the VAT on condoms from 21% to 13.5% was also well covered in the media. This reduction followed significant advocacy work by the IFPA with support from other groups. Confirmation that a legal case challenging Ireland's ban on abortion was accepted for consideration by the European Court of Human Rights also generated much media coverage.

The IFPA teamed up with Bayer-Schering again in 2008 for World Contraception Day on September 26th. The theme was "Your Life, Your Body, Your Choice". Also in September there was significant media focus on the news that the IFPA had to suspend services to medical card clients at its Cathal Brugha Street Clinic because of lack of funding from the HSE. The Government's decision to withdraw the HPV vaccine dominated headlines in November. IFPA undertook significant media and political advocacy work around this issue generating substantial public support for the reinstatement of the vaccine. Other events which generated substantial media coverage include the launch of the FGM Action Plan and the publication of the WiSE UP evaluation report and the SWOP report. An ongoing priority for the IFPA is to raise

awareness of the importance of sexual and reproductive health at home and abroad. We work with partner organisations to develop a stronger commitment to and support for sexual and reproductive health and rights at a national and international level. We advocate for increased access to reproductive health services and seek to address any barriers to service related to age, disability, sexual orientation, nationality, language, culture, geography and gender. Our work seeks to promote a positive, healthy and responsible concept of sexuality and to advance a human rights based approach to all aspects of sexual and reproductive health and rights. At a national level the IFPA is an active member of Dóchas, the Irish association of non-governmental development organisations and in 2008 we were active on the group's HIV/AIDS working group. During 2008 the IFPA co-ordinated the national steering committee on addressing FGM. This culminated in the publication of Ireland's National Plan of Action to Address FGM in November (see Key Projects section for more information).

IFPA also continued to act as the secretariat for the Irish All-Party Interest Group on Sexual and Reproductive Rights, Health, Population and Development. We work hard to keep sexual and reproductive health and rights and development aid on the national agenda. In 2008 the All Party Group had a busy programme of briefings and events throughout the political year including a seminar entitled "Population, Reproductive Health, Environment and the Millennium Development Goals" in June. John Skibiak, Director of the Reproductive Health Supplies Coalition, and

Richard Ottaway, former chairman of the UK All Party Group for Population, Development and Reproductive Health spoke at the event. The event was well attended by senators and TDs, including two former ministers for overseas development aid. Internationally, the IFPA is a member of the International Planned Parenthood Federation (IPPF) and has "collaboration NGO" status with the United Nations Population Fund (UNFPA). We are also members of the European Cervical Cancer Association, EuroNGOs, the coalition of European non-governmental organisations working in the field of sexual and reproductive health and a collaborating partner in the Countdown 2015 project which aims to increase donor support for reproductive health supplies.

Other Achievements in 2008:

- » As a collaborating partner with UNFPA, the IFPA organised the launch of the 2008 State of World Population Report (see Key Events for more information).

- » IFPA delivered a lecture on family planning policies to students on the MSc in Global Health programme in Trinity College Dublin.
- » IFPA attended EuroNGO's AGM and annual conference. Climate change, population and sexual and reproductive health and rights were the focus of the event.
- » IFPA attended a reproductive health in emergencies conference in Uganda organised by RAISE.
- » We worked with Women's Human Rights Alliance towards the production of a shadow report on women's right to health in Ireland for the UN Committee on Economic Social and Cultural Rights.

Educational and Training Department

The IFPA's Speakeasy programme was launched in 2008. Aimed at parents, grandparents and caregivers the eight-week programme is designed to provide parents with information, skills and confidence in talking to their children about relationships and sexuality.

An evaluation of the programme was launched in November. It documented how participants reported increased confidence and knowledge about sex and relationships, in particular in the area of sexually transmitted infections (STIs), contraception and the language used by young people around sexual activity. The report also found that the programme had the added benefit of improving participant's awareness of their own sexual and reproductive health. The highly interactive programme has proved particularly successful at reaching out to groups who normally would not have access to parenting training. An evaluation report of the WiSE UP programme was launched by Minister for Finance Brian Lenihan in June. The WiSE UP (Women in Sexuality Education) programme was designed by the IFPA for women living and working in communities experiencing social exclusion. From 2005 to 2007 the 20-week WiSE UP programme was delivered to 58 women in six RAPID areas as well as to women in Pavee Point. The event generated significant media coverage.

WiSE UP Report Key Points

- » Participants reported increased confidence in discussing sex and sexuality comfortably, openly, and informatively with partners, children, other family members and friends.
- » Participants reported increased confidence in speaking in public.
- » The report recommended the roll out of WiSE UP to other RAPID areas.

The IFPA's comprehensive range of sexual health resources continued to be in demand in 2008. Our contraceptive display kit for sex education trainers and medical professionals was again supported by a range of pharmaceutical companies who donated samples of contraceptive methods. The kit also includes a condom demonstrator and home pregnancy test as well as a range of leaflets and guides. All resources can be ordered through the IFPA — 01 8069444



Youth Initiatives

The IFPA promotes the right of all adolescents and young people to sexuality education, information and dedicated, confidential and affordable sexual healthcare service. We also promote the right of adolescents and young people to make informed choices and decisions regarding their sexual and reproductive health. In 2008 we continued to provide services and expert advice to young people. We were also called upon to give our expert opinion to the Joint Committee on the Constitutional Amendment on Children (see Submissions section). In addition the IFPA ran a number of youth-orientated programmes and initiatives in 2008. Following on from the success of 2007, IFPA hosted another Young Decision Makers Conference in 2008 (see Key Events for more information).

The IFPA's Dance4life programme had another successful year. The HIV/AIDS sexual awareness programme was offered free of charge to schools around Ireland. IFPA brought the programme

to Ireland in 2006 on a pilot basis. In 2008 the programme was delivered to transition year students in eight schools and to two youth groups and reached 369 young people directly. The IFPA formed strong links with a sister Dance4Life project in Zambia. Young people involved in the programme reported that they enjoyed the informal approach of the programme and really engaged with the subject matter.

In September IFPA organised a trip for six young people from the Union of Students of Ireland, Choice Ireland and Cork Women's Right to Choose to attend a conference on abortion rights in France. Hosted by the French Family Planning Association and the IPPF the conference was held during the French Presidency of the EU and was entitled "The Right to Abortion: What is at stake for women in Europe?" and was attended by delegates from all over the EU.

Submissions

The IFPA has earned a reputation as an expert voice in the area of reproductive and sexual health thanks to its excellent track record in providing high quality medical, contraception and crisis pregnancy services. In 2008, the IFPA was called upon to make a submission to the National Office for the Prevention of Domestic, Sexual and Gender - based Violence on the development of its national strategy. IFPA recommended the inclusion of FGM in the strategy. The integration of domestic violence and family planning services and research into domestic and gender-based violence was also recommended.

In a submission to the Joint Committee on the Constitutional Amendment on Children IFPA highlighted the noticeable gap in constitutional protection for the independent rights of the child and stated that it does not support the criminalisation of consensual sexual activity between minors.

In June the IFPA made a submission to the Human Rights Commission in relation to the Third Periodic Report of Ireland under the International Covenant on Civil and Political Rights (ICCPR). The commission was told that the Irish Government's continued disregard for international human rights norms in its abortion policies has resulted in Irish women continuing to have a higher percentage of later abortions, receiving less pre-abortion and follow-up medical care, and suffering from the stigma created by the criminalisation of abortion. IFPA called for greater access to abortion services for all women within the State, particularly when a woman's health and well being is at risk.

Other Key Submissions:

- » In April IFPA presented a report to the Oireachtas Health Committee on the need for a national screening programme for cervical cancer.
- » Submission to Irish Aid through Dochas on humanitarian policy highlighting need for improved gender analysis, the importance of reproductive health supplies and sexual and reproductive needs of adolescents.
- » IFPA was consulted by the Equality Authority for a background paper on stereotyping. IFPA contributions on images of women seeking abortion and the impact of gender stereotyping on sexual health were given priority in the publication.



Key Projects

FGM

On November 25 2008, to coincide with International Day for the Elimination of Violence against Women, Ireland was one of 15 European countries to launch action plans to address female genital mutilation (FGM) in their respective countries. This event was the culmination of years of hard work at the IFPA.

IFPA was asked to develop a national plan to address FGM in Ireland by the EuroNet FGM Association as part of a 15-country project. To achieve this the IFPA brought together 17 diverse organisations to form a steering committee and produced this landmark plan of action. The document stressed the need for an inter-agency approach to address FGM in Ireland and set out three fundamental goals - prevention of the practice of FGM in Ireland, provision of quality health care and support for women and girls who have undergone FGM and contribution to the worldwide campaign to end FGM.

The action plan called for:

- » The establishment of an inter-departmental working group to monitor and evaluate the progress of the Plan of Action.
- » The enactment of legislation to specifically prohibit FGM in Ireland.
- » Recognition that the harmful consequences of FGM are being experienced here in Ireland.

74 people attended the launch, which was held in the Irish Aid Centre on Dublin's O'Connell Street in November.

Drugs Conference and report

IFPA organised a two-day conference entitled "Drug Use: A Reproductive and Sexual Health Perspective" in Dundalk in April. The first conference of its kind in Ireland, the event sought to provide information to medical, nursing and all other professionals working directly and indirectly with the drug using community about the management of reproductive and sexual health issues. The conference formed part of a larger project comprising two training courses focusing on the reproductive and sexual health of the drug using community for counsellors, youth workers and other professionals working in the drugs sector.



Key Events

SWOP

In 2008 IFPA co-ordinated the Irish launch of UNFPA's State of the World Population Report. This year's report was entitled 'Common Ground: Culture, Gender and Human Rights' and was launched on November 12th.

The report focuses on how culture impacts on population trends and how culturally sensitive approaches are essential in promoting sexual and reproductive health. If more culturally sensitive approaches are adopted in development work, practices such as child marriage and female genital mutilation can be ended, the report stated. Sean Hand from UNFPA headquarters in New York presented the report and Senator Fiona O'Malley officiated at the event, which was well attended by ambassadors, politicians, Irish Aid staff, development NGOs and members of the media.



European Cervical Cancer Prevention Week

Irish European Cervical Cancer Prevention Week (ECCPW) took place from the 20th to 26th January 2008. ECCPW proved a huge success. The key achievements included substantial media coverage, a 100 per cent increase in appointments for cervical cancer screenings in IFPA clinics, significant interest from politicians and an invite to make a presentation to the Oireachtas Health Committee on cervical cancer. The IFPA attended the ECCPW summit meeting in Brussels during the week. The week was followed up by a cervical cancer seminar and the distribution of multilingual educational leaflets.

YDM

In July the IFPA hosted the second Young Decision Makers Conference. The conference aimed to get young people to come together to talk about important issues relating to sexual health. Topics covered included access to sexual health services, information on sexual and reproductive issues and their right to confidentiality. The event was attended by 80 people from a range of youth work organisations

from around the country. Doortje Braeken, the Senior Adviser Adolescents/Young people at International Planned Parenthood Federation made a presentation at the conference. Monica Mohjam gave a talk on child marriage and FGM. The conference was opened by Senator Deirdre de Burca and was attended by Minister for Children and Youth Affairs Barry Andrews.

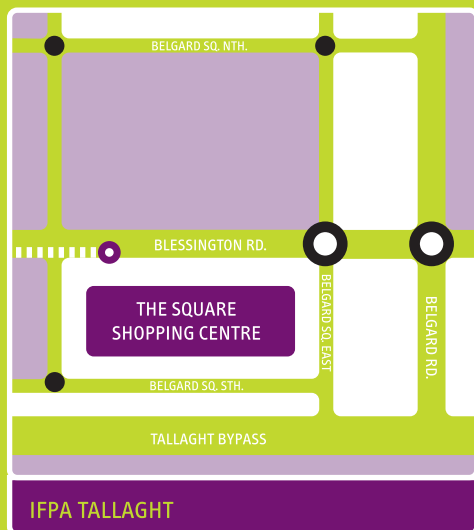

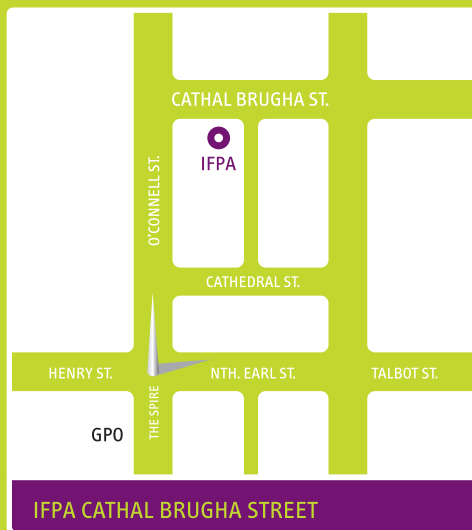
